- 6. Effective 1st JULY 2018, REUSE container deposit are not allow except floating cheque.

DEPOSIT IS REFUNDABLE UPON OUTSTANDING CLEAR (e.g D&D, REPAIR CHARGES, CLEANING CHARGES, etc...).

IF THE CASE THAT THERE'S ANY PENDING OUTSTANDING FROM YOUR END, WE WILL DEDUCT THE AMOUNT FROM CONTAINER DEPOSIT & BALANCE WILL BE CONTRA NEXT SHIPMENT / REFUNDED ACCORDINGLY. HOWEVER, SHOULD THE AMOUNT EXCEED THE DEPOSIT ON HAND, YOUR END ARE URGE TO MADE PAYMENT FOR THE DIFFERENCE. OTHERWISE, DELIVER ORDER (EDO) WILL BE HOLD FOR INCOMING SHIPMENT UNTIL OUTSTANDING SETTLE.
