Implementation of "Sea Cargo Manifest & Transport (SCMT) Regulations w.e.f 1-August -2019"

Dear Customer,

Changes to the Regulations in filing of Sea Cargo Manifest and Transhipment, for Import & Export shipment effective 1st Aug 2018.

With reference to the Central Board of Indirect Taxes and Customs (CBIT) Notification No. 17 / 2019-Customs (N.T.), Customs has made changes to Filing Sea Cargo Manifest for Import, Export and Transhipment, which is scheduled to be into force effective 1st August 2019.

Key highlights of the new revised regulations specify that it is Compulsory & Mandatory for the Shipping Line, Importer, Exporter and other custodians of cargo to comply with the regulation, by strictly adhering to the defined timelines for filing of all cargo arriving and departing any Indian port.

We are summarising for your ready reference the key points and prominent features of the New SCMT Regulations hereunder:

- 1. Arrival Manifest Data to be filed with Indian Customs, 24hrs PRIOR DEPARTURE of the Vessel from EACH FOREIGN Load Port.
- 2. Arrival Manifest Data to be filed for all Containers on Board, including ROB at respective Indian Ports.
- 3. **House Bill of Lading (HBL) Details required in Manifest Data,** in case of Forwarder involved (Since Manifest need to be filed with Indian Customs based on House B/L Data)
- 4. In case of **Switch BL**, **the actual Indian Consignee name & details** need to be provided in Manifest data by the Foreign Load Port.
- 5. Any subsequent changes/amendment after filing of Arrival Manifest will attract penalties as may be applicable by Indian Customs.

Cut off time for SI (Shipping Instruction) submission: -

72 hours working day prior to vessel/voyage ETD Port Klang (not included ETA Saturday, Sunday & Public Holiday)

Cut off time for BL confirmation: -

60 hours before departure from Port Klang (not included ETA Saturday, Sunday & Public Holiday)

Cut off time for Manifest submission: -

48 hours before departure from Port Klang (not included ETA Saturday, Sunday & Public Holiday)

In addition to the above, for Import shipment into India there are additional information fields required against the standard available as per existing Manifest data being received currently.
